

## PRIVACY POLICY

**INTRO.** Clearpool Inc. (“**Clearpool**” or “**we**”/“**our**”) is committed to protecting your privacy through our strict adherence to this policy. This policy sets forth the information collected or to be collected when you use our Website, the interface (the “**Interface**”) for interacting with the Clearpool Protocol (the “**Protocol**”) or when we are contacted by you via electronic means, and the manner by which we collect, use, maintain, protect, and disclose your information. This policy does not address or concern the information that you may provide to any third party who may have their own privacy policies, that you are encouraged to read beforehand.

If you disagree with this policy, you are requested not to access our Website/Interface or to discontinue the use of our Website/Interface forthwith. By accessing our Website, using the Interface, or communicating with us via email, you agree to this privacy policy. This policy may change from time to time so please check the policy recurrently for updates. Your continued use of the Website and the Interface after we revise this policy means you accept those changes.

**COLLECTION.** Clearpool collects information within the Interface directly from you when you provide it to us or when you access the Website or use the Interface. Within the Interface, we may ask you to provide information which may be publicly available on an underlying blockchain as well as information that you provide by (i) filling in forms in the Interface, MetaMask or similar software when requested to do so; (ii) transacting with the Protocol through the Interface; and (iii) typing your addresses.

Technology may be used by us to collect certain details of your access to and use of the Interface by accessing the Website or using the Interface, including without limitation traffic data, generalized location data, logs, and other communication data, your device and internet connection, e.g. IP address, operating system, browser type, or network information, and cookies.

Please be aware that when you use the Interface, other third parties may also use technologies to collect information about your activities or when you use our Website or Interface. The information collected may be associated with your personal information, including your online activities over time and across different websites, apps, and other online services websites. Clearpool does not control any third parties' tracking technologies or how they may be used.

Please be aware that information uploaded and saved on a blockchain are public, irreversible, permanent, or not easily removable. Your transactions and addresses may be disclosed or correlated now or in the future by any party who chooses to do so, including law enforcement agencies.

**USE.** Clearpool uses the information collected from, or provided by, you to give you access to the Interface and its contents, and any other information, products, or services that you request from us, to fulfil our duties and enforce our rights in connection with any agreements executed between you and Clearpool, to provide technical support, and to notify you when updates or changes to our products are readily available.

**DISCLOSURE.** Clearpool may disclose the information received from you without restriction to our subsidiaries and affiliates, to contractors, service providers, and any other third parties used to support our business, to our assignee and successor in title, to comply with any court order, or to enforce our rights arising from any contracts entered into between you and us, including the Clearpool Platform Terms and if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Clearpool, the Protocol, our users, or others.
